I agree that Steve's European Automotive, Inc. has the express lien on the above described vehicle for the exchange of parts and labor furnished under this repair order, including those from any unpaid prior repair order(s) on this vehicle. If I fail to pay such charges, my vehicle will be held in lieu of payment and may become subject to the application of a Garage Keeper's Lien with the State of Michigan. In the event of failure to pay charges when due, I agree to pay, in addition to repair charges, normal shop rates for our time spent in collection efforts plus any reasonable attorney's fees and/or actual costs incurred in collection.
